2. Bids and Tender Documents, signed Physically and/or Digitally with a valid Digital Signature Certificate, are to be submitted **online only** in the designated covers on the web portal <https://etenders.Kerala.gov.in/nicgep/app> of Tenders Kerala
3. Bids should be uploaded only in the **specific BOQ** from available on the web portal against this Tender. Tenders which are not in the prescribed BOQ form are liable to be rejected.
4. Payment of the **Sum amount of EMD + Tender Fee** should be made through **Online Payment** mode as a **Single Transaction** only.
5. An agreement should be executed and signed by the Tenderer in the Kerala Stamp Paper of value Rs.100. A specimen form of agreement is given in the Tender Documents. **Hard Copy of this Agreement** should be sent to the Tender Inviting Authority so as to reach it before the last Date and Time of Receipt of Tenders; otherwise the tenders are liable to be rejected.
6. **Online Opening** of the Tenders will be done on the specified Date and Time through the official portal <https://etenders.Kerala.gov.in/nicgep/app> of Tenders Kerala.
7. All items quoted must comply with the respective Specifications mentioned in the documents uploaded as '**Specifications.pdf**' if any.
