ORDER

Government vide order read above upgraded the Head Clerk post in the Office of the Drugs Inspector, Palakkad and in the Office of the Drugs Inspector, Malappuram as Junior Superintendent.

Accordingly the two senior Head Clerks are promoted as Junior Superintendents and the following promotions, transfer and posting are ordered with immediate effect.

- 1) **Shri. Rajeev C**, Junior Superintendent, Office of the Assistant Drugs Controller ,Trichur is transferred and posted in the vacancy of the newly upgraded post of Junior Superintendent in the Office of the Drugs Inspector ,Palakkad. (Request transfer)
- 2) **Shri. Muhammed Ashraf K A**, Junior Superintendent, Office of the Assistant Drugs Controller , Kollam is transferred and posted in the vacancy of the Junior Superintendent in the Office of the Assistant Drugs Controller ,Trichur vide Shri Rajeev C transferred.(Request transfer).
- 3) **Smt. Savithri K P**, Store Superintendent (Head Clerk), Drugs Testing Laboratory, Thiruvananthapuram is promoted as Junior Superintendent in the scale of pay of Rs. 16180-29180 and posted in the Office of the Assistant Drugs Controller, Kollam vide Shri. Muhammed Ashraf K A transferred.
- 4) **Shri. Rajeevan P**, Head Clerk, Office of the Drugs Inspector, Malappuram is promoted as Junior Superintendent in the scale of pay of Rs. 16180-29180 and posted in the same office in the upgraded post.
- 5) **Smt. Prabha S**, Head Clerk, in the Office of the Drugs Inspector, Palakkad is transferred and posted in the Drugs Testing Laboratory, Thiruvananthapuram as Store Superintendent (Head Clerk) in the promotion vacancy of Smt. Savithri K P.

The pay of the promotees will be fixed as per Rule 28A, Part I, KSR. They should submit option for fixation of pay in the requisite form in a month's time on taking charge of the new post. The incumbents who have already received Higher Grade Promotion in the scale of the promotion post ordered above will not eligible for any pay fixation.

Smt. K. P. Savithri and **Sri.P.Rajeevan** will be on probation in the post of Junior Superintendent for a period of one year duty with in a continous service of two years, w.e.f. the date of assuming charge.

Sri. P. Rajeevan, Head Clerk, Office of the Drugs Inspector Office, Malappuram shall took charge of the post of Junior Superintendent in the same office only after his senior Smt.K.P.Savithri, had taken charge of the post of Junior Superintendent in the office of the Assistant Drugs Controller, Kollam.
